GACUK is pleased to announce a new scholarship for the academic year 2021-2022, named the "Dr Eirini Saroglou-Tsakos Scholarship," offered by 'the Tsakos Foundation".

Applications are invited for postgraduate studies/research in a UK university in Greek Maritime Archaeology. The scholarship, which may be awarded for up to three consecutive years, is intended to cover all, or part of the cost of tuition fees.

Eligibility is limited either to citizens of the Hellenic Democracy and of the Republic of Cyprus or to those of Hellenic ethnicity (Greek and Cypriot Greek). Applicants must hold either a first degree with First Class Honours or equivalent (such as "Arista") from any reputable university, or a second, postgraduate degree with Distinction or equivalent. At least one of these degrees should be in Greek Archaeology

Consideration will be given exclusively to applicants whose research pertains to any maritime aspect of Greek culture from prehistory to the middle of the 19th century. Such research includes but is not limited to Greek island archaeology, ancient Greek trade and trade routes, shipbuilding, shipwrecks, seafaring and life at sea, navies and naval battles, harbours and anchorages, thalassocracies, maritime sanctuaries and cults, ship and marine depictions in art, as well as past perceptions of the sea.
